#### **PRESENTATIONS**

# House Bill 1040 Overview

Ms. Marcy Aldinger provided an educational overview of House Bill 1040. The legislation 1) closes the Main Retirement Plan to [Political Subdivisions & State] new hires, first enrolled, on or after January 1, 2025, and creates a special election window for eligible [State] employees to change plans, 2) establishes Tier 3 in the NDPERS Defined Contribution Plan, and 3) defines how the Main Defined Benefit Plan will be funded.

Ms. Aldinger began by explaining the difference between the Defined Benefit (DB) and the Defined Contribution (DC) plans. She discussed eligibility criteria for the special election window to be held January 1, 2025, to March 31, 2025.

Ms. Aldinger talked through the process for eligible employees who elect to move from the DB to the DC plan. She provided information about the account transfer amounts based on the actuarial equivalent of the accrued benefit. NDPERS will provide eligible members with projections between the Main and Defined Contribution Plan. Participants who elect to move from the DB to the DC during the special election window will be eligible to receive an employer paid incentive into their DC plan..

Ms. Aldinger provided detail about the new Defined contribution Plan 2025, Tier 3, and the mandatory participation for new hires on or after January 1, 2025. She explained what the exceptions are, contributions, vesting, and employer matching funds.

She concluded the presentation by sharing information about how the closed DB plan will be funded and the funding sources.

Discussion followed.

# House Bill 1040 Implementation Update

Ms. Fricke outlined the work efforts and a high-level update on progress made for House Bill 1040 implementation since last reporting at the September board meeting. Activities discussed were weekly meetings with the benefit enrollment and the accounting team, ongoing discussions with Sagitec about vendor questions, more outward facing communications, continued programming and testing, focus on the special election window, bi-weekly meetings with Empower in preparation for the special election window, and meetings with the Retirement Committee, the Employee Benefits Programs Committee, and the League of Cities. The board also discussed in-plan annuities and reviewed a response from legal counsel related to questions raised at the September board meeting.

# 2023 Active Health Care Report

Ms. Katheryne Korom shared the annual Active Healthcare Report for 2023. The report is a compilation of hospital utilization, physician/clinical utilization, and pharmacy utilization data. The combined utilization results in an overall per capita cost increase of 8.7% for the calendar year ending 2023.

An agency-specific report is developed for participant employer groups larger than 100 employees.

# FlexComp Plan Document

Ms. Lindsay Schaf shared an updated plan document for FlexComp. Changes were based on member inquiries over the past year and the updates give clarification to how the plan is being administered. The suggested changes were reviewed by legal counsel and ASIFlex. Changes would be effective January 1, 2025.

# Insulin/Diabetic Supplies Report and Recommendation

Ms. Rebecca Fricke shared the final report and recommendation submitted to the Employee Benefit Programs Committee. As discussed at the September board meeting the required report and recommendation is a result of the passing of SB 2140 during the 68<sup>th</sup> Legislative Assembly, specifically, section 4 of SB 2140 relating to the coverage of insulin drug and supplies. The full report was included in the board materials.

# Sanford Health Plan Update on Humira

Sanford Health Plan will be removing the drug, Humira, from the formulary list effective January 1, 2025. The board reviewed the communication that went out to 20 members impacted by the upcoming change.

# **Collection Services**

Mr. Derrick Hohbein provided background on the process to collect overpayments of retirement benefits and unpaid premiums. NDPERS has utilized the Civil Litigation Department of the Office of Attorney General to collect overpayments on behalf of NDPERS. There are 22 past due accounts totaling \$16,565.85 that are considered recoverable within the Statute of Limitations. Staff is exploring the use of a state contract for collection services to recuperate the outstanding balances. The contractors charge a fee for the services, but staff believes receiving a portion of the recovery is better than no recovery.
