Chairman Seminary called the meeting to order at 8:30 A.M. Roll call was taken, and a quorum was present.

Chairman Seminary called for questions or comments regarding the August 20, 2024, meeting minutes.

PRESENTATIONS

Investment Performance Update

NDPERS Board Meeting September 10, 2024 Page 2 of 9

Mr. Scott Anderson, Chief Investment Officer for RIO, presented a PERS Investment Performance report for the period ending June 30, 2024. He also provided a snapshot of current performance measurements as of September 6, 2024. Mr. Anderson discussed inflation trends and its effect on the market, investment management, asset allocation and asset class performance of PERS trust funds. He concluded his presentation speaking about an initiative RIO is implementing to hire an Asset Allocation Consultant across all plans that would result in overall reduced costs and in the best interest of all clients. Discussion followed.

DEFINED CONTRIBUTION PLAN IMPLEMENTATION

House Bill 1040 Implementation Update

Ms. Fricke outlined the work efforts and a high level update on progress made for House Bill 1040 implementation since the last reporting at the board meeting. Activities discussed were weekly meetings with the benefits and accounting teams, finalizing the 457 Plan Document and 457 Companion Plan Document, continuing a focus on outward facing communications, held staff training kick-off meeting, dedicating a segment of the monthly all-staff meetings for DC plan internal staff education, distributed first "short-clip" to Team ND and participating employers to forward to their employees, continued programming and testing, payroll, and special election window planning sessions. A sample of the special election window communication to eligible employees will be shared with the board at once it is finalized.

In-Plan Annuity Options

An in-plan annuity option is a requirement of HB 1040 that closes the Defined Benefit plan to new hires effective January 1, 2025. The Investment Subcommittee discussed N.D.C.C. §54-52.6-05(3) and §54-52.6-05.1, sections of statute that govern annuity providers. Mr. Derrick Hohbein shared the information that was discussed at the August meeting and the recommendation of the Investment Subcommittee. Callan Consulting provided guidance on three types of products in the institutional retirement market that meet the in-plan annuity requirements of the law. All three were considered based on both their availability on the Empower platform as well as their appropriateness for NDPERS participants. Discussion followed and included a request to bring back analysis and possible advantages of out-of-plan annuity options to a future meeting

457 Companion Plan & 401(a) Plan 2nd Quarter 2024 Report

Mr. Hohbein reported the two plans have 10,765 participants with \$246.2 million in assets. This represents an increase in both the number of plan participants and total assets. He also discussed benchmarks and fund/investment news. The full reports are available on the website.

<u>457 Deferred Compensation Plan Document & 457 Deferred Compensation Companion Plan</u> <u>Document</u>

Ms. Rebecca Fricke reported that staff and legal counsel have completed the review and updates to the 457(b) Deferred Compensation Plan Document and the 457(b) Deferred Compensation Companion Plan Document. The updates ensure compliance with state and federal law related to the implementation of HB to close the Defined Benefit Plan to new hires effective January 1, 2025. Discussion followed.

LEGISLATION / ADMINISTRATIVE RULES

Proposed Administrative Rules

Ms. Fricke gave a report on the status of the proposed Administrative Rules. Staff continue working with the Attorney General's Office on the review of the proposed administrative rules.

There was one rule being proposed due to House Bill 1040 that the Attorney General Office determined NDPERS could not move forward on. The proposed rule was NDAC 71-08-11-08, which NDPERS proposed to define "state employer" and "state governmental unit" for purposes of determining eligibility for the special election window and corresponding incentive along with the required Actuarial Determined Employer contribution (ADEC) employer payment, cannot move forward as they determined these are defined terms. Therefore, NDPERS has removed this proposed rule for final rule submission to Legislative Council. With the removal of this Rule, NDPERS will need to move forward with offering the defined benefit to defined contribution transfer special election window to permanent state employees with no more than 5 years of service, including those state entities that do not receive budgetary approval from the state legislature. For those employees that elect to transfer, NDPERS will charge these entities the amount of the incentive for up to the 3 years if the transferring employee remains employed by the entity. In addition, NDPERS will be charging these same entities the required ADEC employer contribution.

Ms. Fricke shared this information with the Administrative Rules Committee at their September 4th meeting, and was available to answer questions regarding the proposed rules. The information will also be shared with the Retirement Committee and Employee Benefits Programs Committee.

The Assistant Attorney General asked that a Regulatory Analysis be performed to determine if the proposed rules are expected to have an impact on the regulated community in excess of \$50,000. Staff determined that they would not.

The board began discussing options to hold regular monthly meetings during legislative session given the 11-person board is made up of 4 legislators and the quorum requirement for a NDPERS board meeting is 8 trustees. Regular meetings are necessary to give staff guidance on bills being considered during Legislative Session in addition to regular business topics that require board action. It may be necessary to hold board meetings outside of normal business hours to accommodate the responsibilities and schedules of the legislative members on the board. This topic will be brought back to the October 8th meeting for further discussion.

Update Regarding Industrial Commission Letter

Ms. Fricke provided an update to a matter that was discussed at the February 2024 meeting related to the Industrial Commission. Staff received advice from the federal tax consultant, Ice Miller. Programming is necessary to avoid future potential issues.
